## METHODOLOGY

### Introduction

The QLFS sample covers the non-institutional population except for workers' hostels. However, persons living in private dwelling units within institutions are also enumerated. For example, within a school compound, one would enumerate the schoolmaster's house and teachers' accommodation because these are private dwellings. Students living in a dormitory on the school compound would, however, be excluded.

### Survey requirements and design

The Labour Force Survey frame has been developed as a general-purpose household survey frame that can be used by all other household surveys irrespective of the sample size requirements of the survey. The sample size for the QLFS is roughly 30 000 dwellings.

The sample is based on information collected during the 2001 Population Census conducted by Stats SA. In preparation for Census 2001, the country was divided into 80 787 enumeration areas (EAs). Some of these EAs are small in terms of the number of households that were enumerated in them at the time of Census 2001. The Stats SA household-based surveys use a Master Sample of primary sampling units (PSUs) which comprises EAs that are drawn from across the country. For the purposes of the Master Sample, the EAs that contained fewer than 25 households were excluded from the sampling frame, and those that contained between 25 and 99 households were combined with other EAs of the same geographic type to form primary sampling units (PSUs). The number of EAs per PSU ranges between one and four. On the other hand, very large EAs represent two or more PSUs.

The sample is designed to be representative at provincial level and within provinces at metro/non-metro level. Within the metros, the sample is further distributed by geography type. The four geography types are: urban formal, urban informal, farms, and tribal. This implies that, for example, within a metropolitan area the sample is designed to be representative at the different geography types that may exist within that metro.

The current sample size is 3 080 PSUs. It is equally divided into four subgroups or panels called rotation groups. The rotation groups are designed in such a way that each of these groups has the same distribution pattern as that which is observed in the whole sample. They are numbered from one to four and these numbers also correspond to the quarters of the year in which the sample will be rotated for the particular group.

The sample for the redesigned Labour Force Survey is based on a stratified two-stage design with probability proportional to size (PPS) sampling of primary sampling units (PSUs) in the first stage, and sampling of dwelling units (DUs) with systematic sampling in the second stage.

### Sample rotation

The sampled PSUs have been assigned to 4 rotation groups, and dwellings selected from the PSUs assigned to rotation group '1' are rotated in the first quarter. Similarly, the dwellings selected from the PSUs assigned to rotation group '2' are rotated in the second quarter, and so on. Thus, each sampled dwelling will remain in the sample for four consecutive quarters. It should be noted that the sampling unit is the dwelling, and the unit of observation is the household. Therefore, if a household moves out of a dwelling after being in the sample for, say 2 quarters, and a new household moves in, then the new household will be enumerated for the next two quarters. If no household moves into the sampled dwelling, the dwelling will be classified as vacant (unoccupied).

At the end of each quarter, a quarter of the sampled dwellings rotate out of the sample and are replaced by new dwellings from the same PSU or the next PSU on the list. A total of 3 080 PSUs were selected for the redesigned LFS, and 770 have been assigned to each of the four rotation groups.

## Weighting Methodology

### Adjustments

The Gross Flow Estimation for Q3-Q4 2013 was based on data from only three overlapping panels, i.e. rotation panels 1, 2, and 3. The QLFS final full weights ('full\_wgt') from time T were therefore adjusted by a factor of  $\frac{4}{3}$  to account for the non-overlapping panel.

A 'Person non-match' adjustment factor was calculated based on whether the person records at time T were matched or not with a person record at time T+1 as well as the persons in labour force age at time T but were reported as younger than 15 years at time T+1.

The adjustment factor was defined as follow:

$$(Person\_NonMat\_Adj)_i = \frac{n_i^{(mat\_rel)} + n_i^{(non\_mat\_rel)}}{n_i^{(mat\_rel)}} \tag{2.1}$$

Where  $n_i = n_i^{(mat\_rel)} + n_i^{(non\_mat\_rel)}$  is the sum of the weights of the matched and non-matched persons including those with age younger than 15 at time T+1 in adjustment cell i and  $n_i^{(mat\_rel)}$  is the sum of the weights of the persons matched between time T and T+1 with age older than 15 years.

After excluding the non-matched person records at time T from the data file; the QLFS final full weights were further adjusted by applying the 'person non-match' adjustment factor within the respective adjustment cells.

The adjustment cells were defined by the rotation group as well the demographic variables Age, Gender and Race. Rotation group had three categories, Age had three categories: 15-34, 35-64 and 65+, Race had four categories: 1=African/Black, 2=Coloured, 3=Indian/Asian, 4=White and Gender had two categories; which resulted in a total of 72 adjustment cells.

### Calibration

The calibration totals were created using the calibrated weights at time T; the calibration cells were defined as Age group by Gender by Labour Force Status at national level, and Age group by Labour Force Status at provincial level. The Age group categories used were 15-34 and 35-64, Gender categories were Male and Female, and the Labour Force Status categories were Employed, Unemployed and Not Economically Active (discouraged and other not economically active).

There were two Age groups, two Gender categories and three Labour Force Status categories. The resulting cross classification cells were 12 at national level and 54 at provincial level.

The adjusted final weights were calibrated to the created population totals at time T as control totals for persons aged 15-64. It should be noted that the calibration totals only include ages 15-64, and not 65 and above. Calibration could not be done for the 65 and above due to the very low and zero counts in the cells of age 65 and above.

**Final Weighted Data**

The final Q3-Q4 2013 Gross Flow Estimation Weighted data with the calibrated weights contain 35 744 person records.

**Limitations**

The calibrated weights provided should be used with caution to the following limitations:

1. The reference period for the Panel data analysis is time T.
2. The demographic variables at time T are assumed to be correct and should be used for the analysis.
3. For analysis purposes, the final Calibrated weight is 'FULL\_CALWGT'.
4. Estimates at aggregate levels, such as the broad age groups, gender and labour force status only, will be comparable to the initial published estimates.
5. Estimation can only be done for ages 15-64.

**The data file**

The data file contains information on sections 1, 2, 3, 4 and 5.

Each section contains the following information for each variable:

**Description of variables**

**Descriptive name:** This is a short description of the variable with the variable name in brackets.

**Position of the variable:** The position of a variable within a record is recorded in the format (@xxx y.). '@xxx' indicates that the variable starts at position (i.e. column) xxx, and 'y' indicates the length of the field.

**Final code list:** The range of valid values for variables. For continuous variables it only reflects the upper and lower limits.

**Not applicable:** The code for 'missing' values is given for each variable (□ = Not applicable).

**Note to users:** Additional information for further clarity on questions.

## Naming Convention for panel data

### Panel\_Q32013\_Q42013

Identifies the period for which the panel has been constructed for example Panel\_Q32012\_Q42012 refers to a panel constructed for the period between quarter 3 of 2012 (time T) and quarter 4 of 2012 (time T+1).

#### Variable name

Identifies the variable name and the quarter to which it pertains, for example **Status\_Q32012** refers to the Status variable in the 3rd quarter of 2012.

#### Note to users

This question was asked for each person found in the selected dwelling. Those who were not household members (those who had not spent at least four nights per week during the last four weeks) were excluded from the data (2 = No). The instruction in this question was to end the interview for those who had answered 'No' to this question. It is by means of this question that household members are identified within the selected dwelling.

In this instance, they had to ask the respondent the gender of each member of the household without any assumptions.

**Note to users**

This question was asked to determine the population group of persons from the selected dwelling units. The respondent had to answer for each member and the enumerator was not to make any assumptions. The enumerator was also instructed not to come to any conclusions, which may be influenced by his observation or using people’s names during the interview. This question may seem very sensitive to some respondents, especially in this post-apartheid era, but it is important to find out the composition of the South African population.

**Note to users**

Enumerators were instructed that it was only those qualifications already obtained which had to be entered. That means the current level of study with which a person was still busy, was not applicable. It was very important to complete each record even if the person had not attended school. Enumerators were instructed to record diplomas and certificates that were of at least six months' duration. If the answer to Q1.7 is code 98 or 00-12 or 29-30, the instruction is to go to Q 1.9. If code 13-28 is selected, the instruction is to go to Q1.8.
